On the passing of Rev. Dr Ian Mavor OAM (1938 - 2015).

Rev. Dr. Ian Mavor OAM passed away peacefully at Hopewell Hospice Arundel on 12 April 2015 after fighting liver cancer. He was 77 years old.

Rev Dr Ian Mavor was a community champion, whose strong legacy and advocacy will continue to live on. In 2002, Ian was awarded a Medal of the Order of Australia (OAM) "For service to the community through a range of church, social welfare, education and health groups."

Ian served as CEO and Executive Director of Hopewell Hospice Services Inc., which includes Hopewell Hospice, Hopewell Outreach Service, Paradise Kids, the Living Well Centre and Hopewell Educational Services, a College of Transformative Education.

I was honoured to work alongside Ian and Deirdre not only to promote the Hopewell Hospice, but also to promote and raise funds for Paradise Kids, a charity they established to provide grief, loss and illness support programs for children, youth and their families from the Gold Coast community.

Ian was a Teacher and University Lecturer, Master of King's College within the University of Queensland, Dean of the Brisbane College of Theology, Principal Education Officer in Education Queensland and Executive Director of Lifeline Gold Coast.

His fulfilled and inspiring life, work and service to others can be summarised in the motto he lived by: "To love another person is to see the face of God".

Rev Dr Ian Mavor OAM will always be remembered as a loved husband by his wife, Deirdre, a loving father, stepfather, father in law and grandfather.

3.1 MAYOR'S MISSION TO GLASGOW AND WINDSOR 13-20 JULY 2015 – POST COMMONWEALTH GAMES

Councillors,

As the 2014 Commonwealth Games have been over for a number of months now in Glasgow, I am keen to meet with the Lord Provost and to tour their city and games facilities to gain a reflective insight into the lessons learnt by the city in hosting this international event. Discussion on the legacy lessons learned will be invaluable for the Gold Coast's successful hosting of the 2018 Commonwealth Games and beyond.

As such, I propose that I travel to Glasgow to meet with the Lord Provost herself and other key executives who were instrumental in planning and executing the Commonwealth Games as well as realising the lasting legacy benefits post Games.

I have also been invited to Windsor to survey the progress of The Queen's Walkway, upon which you are aware the Gold Coast's Commonwealth Walkway is to be modelled and to personally receive the official final place marker which will be used to complete walkway at the Council Chambers in Bundall. I intend to meet with the Mayor of Windsor, Cr Richard Kellaway, to discuss maximising tourism outcomes regarding the Commonwealth Walkway and related matters.

It was a pleasure to join with the Governor-General, His Excellency General the Honourable Sir Peter Cosgrove AK MC (Retd) to lay the first piece of the Gold Coast's Commonwealth Walkway.

The interactive walkway is an initiative of Her Majesty The Queen, who has given permission for the creation of walkways in cities throughout the Commonwealth, marked with her personal Royal cypher.

An embossed metal interpretation panel, similar to the ones outside Buckingham Palace and other London landmarks, marks the start of the walkway in Davenport Street, Southport.

“The walkway will be completed in stages and, in time, I hope it becomes a local treasure.

This is yet another important milestone for our city in the lead up to the Gold Coast 2018 Commonwealth Games and will serve as an active legacy to the event.

The 10 kilometre route starts at the Southport Chambers and finishes here at Evandale.

There will be up to 40 brass markers along the walkway at sites of interest while a smartphone app will provide information about the site's significance.

The walkway is expected to be officially opened before the April 2018 Games.

**QUESTION:**

What Costs are associated with the installation of Animals with Attitude sculptures?

**Answer:**

Council has approved numerous LAWS allocations for the purchase and installation of koala sculptures as part of Currumbin Wildlife Hospital's Animals with Attitude Sculpture Trail. Typically, \$8,000 is being allocated for the reinforcement and installation of the koala sculptures in various locations across the City.

The cost to (permanently) install each koala sculpture includes the following;

- filling of sculpture with foam (this minimises damage from vandalism)
- delivery to site
